PARISH RELIGIOUS EDUCATION PROGRAM (PREP) PARENTAL STATEMENT OF COMMITMENT

I understand that I am the first educator of my child(ren) in the Catholic faith. At Baptism I made a solemn commitment to raise my child(ren) "in the practice of the faith" and participate in the life of the Church.

This commitment to help my child(ren) nurture their relationship with Christ is lifelong and involves more than sending them to PREP classes. I understand that a lived faith relationship with Christ includes celebration of the Sunday Mass, a life of prayer, knowledge, service and a commitment to love Christ with our whole heart, mind and soul.

I understand that the volunteers of the Parish Religious Education Program are here to be companions in assisting me in nurturing my child(ren)'s faith. I understand the following to be important and necessary to this commitment to Christ and promise to:

- Make **Sundays Matter** by:
 - celebrating Mass weekly (frequently)
 - spending time together as a family
- Make **JESUS Matter** by:
 - putting Him first in my life and that of my child(rens)
 - talking to Him in Prayer (*teach and pray with my child the traditional prayers of our Catholic faith and other forms of prayer*)
 - faithfully preparing my child and family for the Sacraments of Reconciliation, Holy Eucharist and Confirmation
- Make **PREP Class Matter** by:
 - Attending class each week (*5+ absences may require your child to remain at the same level*)
 - Arriving on time for class
 - Coming prepared (*bring the "4 B's" - Book, Binder, Bag, and Bible*)
 - Completing assigned "God-work"
 - Encouraging my child(ren) to fully participate in learning, praying, and engaging in class activities
 - Communicating with my child(ren)'s catechists, PREP coordinator and pastor
